

Terms & Conditions

By entering the 'Farm World App Giveaway' ('the Competition'), you agree to the following terms and conditions of entry (the 'Terms and Conditions'):

1. **Standard Terms**
 - a) Information on how to enter forms part of the Terms and Conditions.
2. **Who can enter?**
 - a) Subject to clauses 2a and 2b, entry is open to all residents of Australia.
 - b) Directors, officers, management and employees (and the immediate families of directors, officers, management and employees) of the Promoter or of the agencies or companies associated with the Competition are not eligible to enter.
 - c) Entrants must be over the age of 18.
3. **How to enter**
 - a) The Competition commences on Friday 20 February at 7pm (AEDT) and concludes on Friday 27 March at 10:30am (AEST) ("the Competition Period").
 - b) Entries must be received during the Competition Period. The Promoter takes no responsibility for late, lost, incomplete, incorrectly submitted, illegible or misdirected entries or for any delays or failures in any telecommunications service or equipment.
 - c) To go into the Competition, entrants must purchase tickets through the Farm World App, thereby affording the parties permission to send updates and information post promotion.
4. **Prize**
 - a) There is 15 prizes on offer. Comprising the following:
 1. A \$50 cash card voucher (4 available)
 2. Rodeo VIP Ticket Upgrades (Adults Only) 6 available valued at \$200 per person.
 3. Ticket refunds up to the value of \$65 (5 refunds available)
 - b) Except as otherwise indicated, all amounts stated in these conditions are stated in Australian dollars.
 - c) The winner must, on request by the Promoter, provide evidence which, to the reasonable satisfaction of the Promoter, demonstrates that the winner is an eligible entrant (as per clause 2a, 2b and 2c) and has complied with the Terms and Conditions.
 - d) The Prize must be taken as stated and no compensation will be payable if a winner is unable to use the Prize as stated. If a winner is unable to satisfy the Terms and Conditions or the Prize is not utilised or able to be taken within the specified timeframe, the Prize will be forfeited by the winner and cash will not be awarded in lieu.
 - e) The Prize is not transferable, exchangeable or redeemable for cash. If the Prize is unavailable, the Promoter reserves the right to substitute the Prize or an item (or items) of equal or greater value. Any taxes (other than GST, if any) which may be payable as a consequence of a winner receiving the Prize are the sole responsibility of the winner.
 - f) The Promoter does not cover any additional costs incurred by the winner including hotel room incidentals, transport, travel insurance and any other costs incurred that are not specified within the Terms and Conditions.
 - g) The Rodeo VIP ticket upgrade is for adults only. Two tickets will be provided to each winner (3 winners).
 - h) Ticket refunds are up to the value of \$65.
 - i) Lost or stolen cash cards will not be replaced. Not redeemable for cash.
5. **How to win**
 - a) Each eligible entry received within the Competition Period will be entered into a random draw.
 - b) Draws will be conducted weekly during the Competition Period, with prize allocation determined by the Promoter at Lardner Park, 155 Burnt Store Road, Lardner, Victoria 3821. The winner will be notified by email.
 - c) The Promoter's decision is final and the Promoter will not enter into correspondence regarding the Competition result or any other decisions the Promoter makes in connection with the Promotion.
 - d) Prizes will be awarded to the person named on the ticket purchase.
 - e) Should an entrant's contact details change during the Competition Period, it is the entrant's responsibility to notify the Promoter.

- f) If the Prize remains unclaimed after 2 business days of notification being given, the Promoter may withdraw the Prize and award it to an alternative entrant by conducting an unclaimed prize draw.

6. Liability

- a) The Promoter and its associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, misadventure, accident, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence) in connection with this Competition or accepting or using any Prize, except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).
- b) Subject to any restrictions at law, the liability of the Promoter however arising is limited to the total value of the Prize.
- c) The Promoter is not responsible for any technical error that may occur during the administration of this Competition including but not limited to any omission, interruption, deletion, defect, delay in operation or transmission, communications, mobile or satellite network failure, theft or destruction or unauthorised access to or alteration of entries.
- d) If, for any reason, this Competition is not capable of being conducted as planned, including but not limited to, due to tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the Promoter, which corrupts or affects the administration, security, fairness, integrity or proper conduct of this Competition, the Promoter reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the Competition.
