

## Terms & Conditions

By entering the 'Patron Survey Giveaway' ('the Competition'), you agree to the following terms and conditions of entry (the 'Terms and Conditions'):

1. **Standard Terms**
  - a) Information on how to enter forms part of the Terms and Conditions.
2. **Who can enter?**
  - a) Subject to clauses 2a and 2b, entry is open to all residents of Australia.
  - b) Directors, officers, management and employees (and the immediate families of directors, officers, management and employees) of the Promoter or of the agencies or companies associated with the Competition are not eligible to enter.
  - c) Entrants must be over the age of 18.
3. **How to enter**
  - a) The Competition commences on Friday 17 April at 9am (AEDT) and concludes on Friday 24 April at 5pm (AEST) ("the Competition Period").
  - b) Entries must be received during the Competition Period. The Promoter takes no responsibility for late, lost, incomplete, incorrectly submitted, illegible or misdirected entries or for any delays or failures in any telecommunications service or equipment.
  - c) To go into the Competition, entrants must complete the Farm World Patron Survey, thereby affording the parties permission to send updates and information post promotion.
4. **Prize**
  - a) There is 1 prizes on offer.

  - b) Except as otherwise indicated, all amounts stated in these conditions are stated in Australian dollars.
  - c) The winner must, on request by the Promoter, provide evidence which, to the reasonable satisfaction of the Promoter, demonstrates that the winner is an eligible entrant (as per clause 2a, 2b and 2c) and has complied with the Terms and Conditions.

  - e) Should an entrant's contact details change during the Competition Period, it is the entrant's responsibility to notify the Promoter.
  - f) If the Prize remains unclaimed after 2 business days of notification being given, the Promoter may withdraw the Prize and award it to an alternative entrant by conducting an unclaimed prize draw.

## 6. Liability

- a) The Promoter and its associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, misadventure, accident, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence) in connection with this Competition or accepting or using any Prize, except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).
- b) Subject to any restrictions at law, the liability of the Promoter however arising is limited to the total value of the Prize.
- c) The Promoter is not responsible for any technical error that may occur during the administration of this Competition including but not limited to any omission, interruption, deletion, defect, delay in operation or transmission, communications, mobile or satellite network failure, theft or destruction or unauthorised access to or alteration of entries.
