5. Event Changes

Where an event is cancelled, refunds will be managed in accordance with the event's cancellation policy and Australian Consumer Law.

We reserve the right to refuse entry or remove any person who:

- behaves in a disorderly or unsafe manner;
- damages property;
- fails to comply with venue rules;
- poses a risk to the safety of others.

You consent to your image being used by us for promotional, marketing and archival purposes unless you notify us otherwise before the event.
